## Capgemini Signs An Extensive Infrastructure Outsourcing Agreement With Kadaster<sup>1</sup> In The Netherlands

Paris, Utrecht, 17 July 2013 – Capgemini, one of the world's foremost providers of consulting, technology and outsourcing services, today announced that its Dutch subsidiary, Capgemini Nederland B.V. has signed an infrastructure outsourcing agreement with Kadaster, the Netherlands' Cadastre, Land Registry and Mapping Agency. The agreement includes the outsourcing of Kadaster's workplace services, office automation, and datacenter services to Capgemini. The contract has an estimated value of 100 million Euros over a 6-year period. The contract includes two options for a two-year extension.

Kadaster wants to outsource the management of its generic infrastructure components to a service provider whose core competencies include infrastructure services. Kadaster expects to be able to better guarantee the continuity of its own service delivery. Moreover, outsourcing enables Kadaster to increase its innovative powers by making use of the expertise of Capgemini, where technology is at the heart of business.

Both parties have agreed that specific employees of Kadaster's own data center can transfer to Capgemini on a voluntary basis. The agreements that have been closed with the unions and the Workers Council are part of the contract.

Dorine Burmanje, CEO Kadaster said: "After a careful preliminary phase, we have succeeded, together with trade unions, Works Council and Capgemini, in building a solid foundation for outsourcing our infrastructure services and providing a sound perspective for all staff involved. We have full confidence in an excellent partnership with Capgemini for the future."
