Provimi harmonizes global organization with SAP and Capgemini

Capgemini manages and implements ERP solution for Provimi - a world leader in animal feed - to streamline corporate activities across 30 countries*

Rotterdam/Utrecht, February 24, 2010 – Provimi, an international provider of nutritional solutions for animals, is streamlining its finance and logistics operations across 80 plants in 30 countries utilizing SAP software. The solution is being implemented by Capgemini Nederland B.V., (“Capgemini”), a subsidiary of the Capgemini Group, one of the world’s foremost providers of consulting, technology and outsourcing services and will be managed by Capgemini Outsourcing BV. This implementation is expected to enable Provimi to transform from a decentralized organization to a unified global company. Provimi offices in the U.S., Canada and The Netherlands were among the first countries to use the new software. The locations in Spain and Portugal started using SAP in December 2009, and at the moment the implementation in Latin America is being carried out.

Provimi wanted to improve its internal collaboration. The company’s local branches previously worked with different IT systems across the company worldwide. Provimi faced the challenge of creating a more coherent organization, and providing top management with better insight into corporate data such as cash flow, financial results and operational targets. To streamline operations, in 2008 Provimi launched its ‘One Provimi’ strategy, also involving the introduction of a new IT environment. Thanks to the detailed program planning, today many countries have already started to use the new SAP software, and more importantly, the implementation is on schedule in terms of timing and budget.

Emiel van Schaik, Senior Vice President Manufacturing and Consumer Industries at SAP, said: “*The SAP software streamlines business processes effectively and delivers improved internal reporting within Provimi. This makes it possible to benchmark the performance of the different production plants. It also gives Provimi a better understanding of the geographies where it can improve its profit margins. With SAP ERP, an integrated business model can be created and copied in other markets.*”
