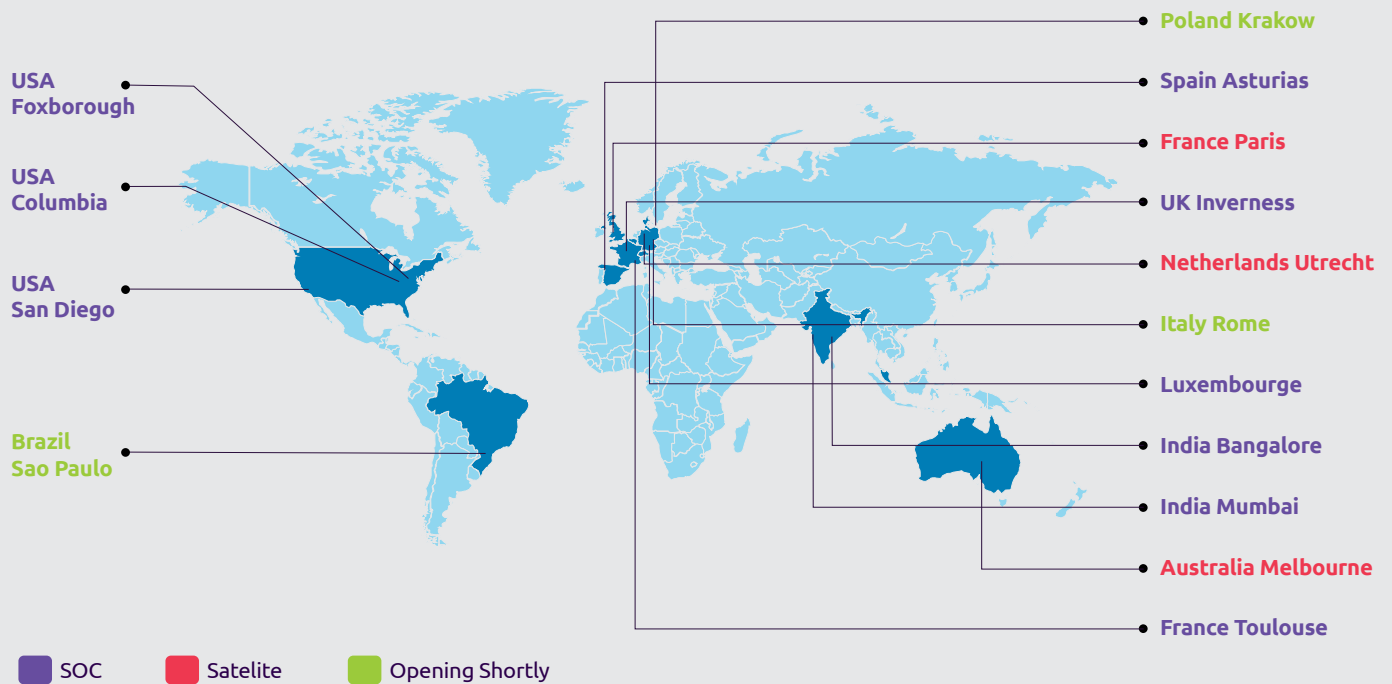

The **Optimize** services include Remediation Support to plug the gaps identified in the Manage phase; Failure Impact Analysis to evaluate the impact to the business of a failure to comply with a given regulation; and External Audit Support to get certified against security standards.



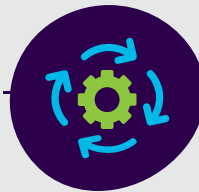

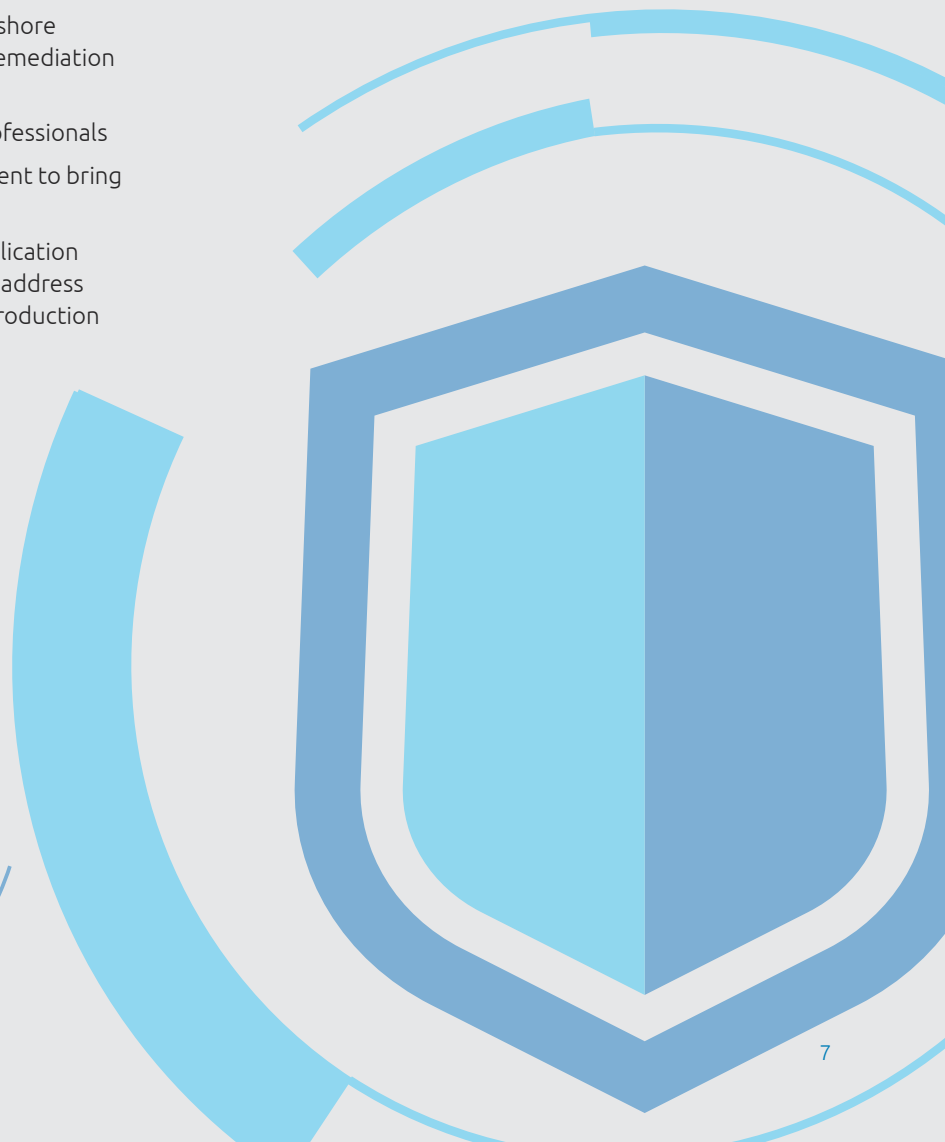
